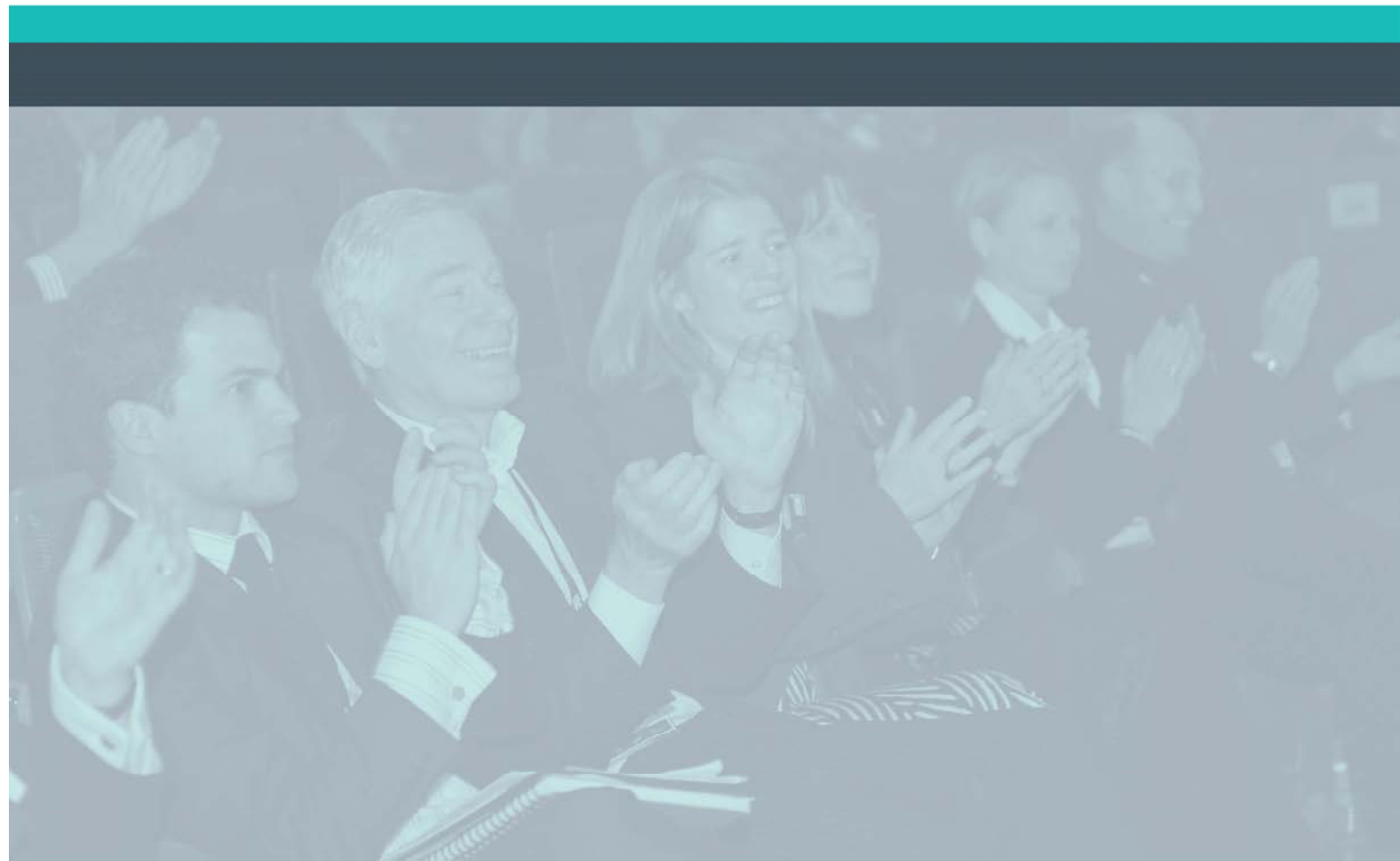

Applying for Membership

1. Please read the Membership Categories set out below and select the appropriate category.
2. All applications are considered by the Membership Committee which meets periodically during the year. The committee's decision on applications is final. It should be noted that from time to time certain categories may become full and applicants may have to be placed on a waiting list.

Membership Categories

1. Corporate Membership

This is open to:

- (a) Organisations (including consultants representing principals) responsible for the development, refurbishment or management of, or being owners of, shopping centres
- (b) Funding institutions having investments in shopping centres
- (c) Retailers
- (d) Local Government authorities
- (e) Any business engaged as a professional adviser or main contractor on retail projects to such organisations, funding institutions, retailers and local authorities

(f) Any business engaged as a subcontractor on retail projects or supplier or otherwise engaged in a trade, profession or industry connected with the shopping centre industry

2. Affiliate Membership

This is open to:

- (a) Employees, directors and partners of Corporate members
- (b) Shopping Centre Managers
- (c) Employees of Local Government authorities
- (d) Employees of Retailers
- (e) Such other persons or organisations as may in the opinion of the Board assist in promoting the objectives of BCSC

BCSC Subscription Rates

The BCSC subscription year runs from January each year. The annual subscription for each category of membership for the current year is as follows:

Corporate member	£770	Affiliate member	£135
*Affiliate member (under 35)	£80	Retired member (non-practising)	£80

Members outside the UK

There is a special subscription for all members resident outside the United Kingdom, with the current fees as follows:

Corporate overseas	£260
Affiliate overseas	£110

Payment should be made by bank draft in pounds sterling drawn on a London bank.

Inland Revenue

Members paying subscriptions personally are reminded that BCSC is included in the list of Approved Bodies maintained by the Inland Revenue. The subscription can consequently be included as an allowable expense for annual return purposes.

Admission of Members through the year

For those admitted to membership after 1 January, the following fee proportion is payable:

1 January - 30 April Full Fee

1 May - 30 September

A member admitted from 1 May - 30 September will pay 150% of the annual subscription, providing membership through to the end of the following membership year.

1 October - 31 December

A member admitted from 1 October until 31 December will pay 125% of the annual subscription, providing membership through to the end of the following membership year.

Value Added Tax

VAT at 20% is payable on all the above subscriptions.
