- Sliding scale fees are based upon the size of your centre using information from BCSC and EGI. These fees apply only to staff employed directly by a shopping centre (e.g. shopping centre manager, marketing, operations, facilities etc.)
- Other delegates pay the standard fee rate. Such delegates may be those who work for owners, managing agents, commercial organisations or are from retailers or suppliers etc.
- All colleagues bookings must be made in conjunction with one category 1 delegate booking from the same/most relevant centre. Applies to shopping centre employed colleagues and asset managers/surveyors. Any number of colleagues delegate bookings can be made in conjunction with just one category 1 delegate booking.
- Applies to any members of a public sector organisation.
- BCSC diploma students - applies to BCSC Shopping Centre Management Diploma students who start year 1 or 2 in 2010.
- The non-member fee covers an introductory membership package for delegates who are not individual members of BCSC but whose employer is a corporate member.
